

PENTAIR CREDIT VOUCHER REFUND OFFER TERMS AND CONDITIONS

Your refund will take the form of a credit voucher that is valid until 15 October in the sales outlet where you made your initial purchase.

Limited offer in participating sales outlets.

TO TAKE ADVANTAGE OF THE OFFER:

- 1 - **PURCHASE** a piece of Pentair or Sta-Rite equipment in a participating sales outlet between 15/04/2022 and 16/07/2022 (inclusive) that is among the eligible products (see table overleaf).
- 2 - **VISIT** pentairpooleurope.com/promo before 31/07/2022 to apply for your credit voucher refund by supplying all the requested information.
- 3 - **DOWNLOAD THE PHOTO OR SCAN OF THE ORIGINAL PURCHASE INVOICE** that indicates the date of purchase, product purchased and the name of the sales outlet.
- 4 - **DOWNLOAD A PHOTO OF THE** cut-out barcode of your product and specify its purchase price.

If the submission is compliant, the Participant will receive their credit voucher via email within three to four weeks. This period is indicative. **This credit voucher will be valid until 15 October 2022 and can be used only at the sales outlet where the first purchase was made. Any other form of refund is excluded.**

All Participants are strongly advised to keep their original proofs of purchase as they may be asked for these items at a later date.
